#### **EVENT DESCRIPTION**

The 2024 Gingerbread House Challenge will take place at The Village at Woods Edge from Wednesday, December 4 through Tuesday, December 17. Team up with your friends, family, or coworkers and display your holiday spirit and creativity by constructing a gingerbread house for a good cause. Entries will compete online and at a closing reception event to see which team will be crowned the Gingerbread Champion. Every \$1 donation from our community counts as one vote towards your team's entry!

#### **ENTRIES AND EVALUATION**

#### Theme and Design:

The 2024 theme for contest entries is "Hometown Holiday." Entries are not limited to the structure of a traditional house. Competitors are welcomed and encouraged to uniquely design their entry for the competition as long as the entry is in keeping with the competition rules and procedures. Examples include designs of local businesses, schools, parks, and landmarks

#### Size Limits:

Entry must be placed on a base. Entries combined with the base must not be larger than 24 inches high, 24 inches wide, and 24 inches long. We suggest using ½" or ¾" plywood as a base for your entry. Use of pegs or risers on the bottom of the base is encouraged for ease of transport but not required. If you wish to install "legs" on the underside of your base, the legs are considered as part of the base and should not cause the entry's height to exceed 24 inches.

#### Materials:

All visible elements of your entry must be edible; interior structures are allowed to be made of non-edible material. The main structure of your entry must be constructed from gingerbread, some of which should be exposed. Gingerbread may be homemade or pre-made kits may be used.

Edible materials are not limited to candies and icings. Creativity in using other edible materials are encouraged - think pretzels, cereals, rice krispee treats - anything is possible! Handmade elements are encouraged. Note that refrigeration for entries will not be provided. Entries will be on display for 2 weeks.

Power sources will not be provided. Should you choose to add lighted or powered elements, they should be battery powered. Non-edible materials such as paint and/or ribbon are approved only to decorate the outer edge of your base (not to exceed the length and/or width of the base). All structures must be free standing with the ability to be viewed on all sides.

#### **Entry Narrative:**

Each team is required to submit a brief narrative no later than Monday, December 2. Share why your design is the best! How did you decide on your design? What does it say about your organization or team? Narratives will be included in social media posts and displayed with the houses that can be viewed by the public. Please keep your narrative to 200 words or less.

#### **Community Choice Voting:**

Each entry will be on display at the Village at Woods Edge to be viewed by the public from December 5-17. Displays will include the name of the team, the submitted narrative, and a link to vote online while making a donation. Each dollar donated counts as one vote. Donors will choose which Gingerbread House team entry to designate their vote for when donating online. Online voting will open on Friday, December 6 and will end at midnight on Monday, December 16. Links for voting will be posted on social media, with photos of each entry - teams are encouraged to share and ask for support for their entry.

At the reception event on Thursday, December 17, all entries will be on display. Teams and the community are invited to attend to cast their final votes and see which team is crowned the Gingerbread Champions. We encourage teams to have representatives present at the reception to drum up excitement and inspire votes for their entry, however it is not required.

#### Awards:

The first place "People's Choice" winner will be determined by donations collected and will receive a trophy, along with the bragging rights as the Gingerbread Challenge Champions! A panel of judges will also pick additional entries to receive award certificates in the following categories: Best Use of Theme, Most Creative, Most Festive, Most Detailed, and Judge's Choice.

#### REGISTRATION

#### Teams:

Due to spacing limitations, the number of entrants will be capped at 15. You are encouraged to submit your entry form early and before the deadline to ensure entry into the competition. To be eligible for the competition, a completed and signed copy of the Competitor Entry Form must be received by email at <a href="mailto:director@franklinunitedway.org">director@franklinunitedway.org</a> prior to 11:59PM on Friday, November 29, 2024.

Teams are limited to 2-6 participants. Individuals will not be considered. The Competitor Entry Form must be signed by all members of the team (and parent/guardian where necessary), and one member must be designated the Team Captain. Team Captains must be older than 18 years of age at the time of the competition date and all team members must be committed to only one team.

#### **Entry Fee:**

To complete registration, your team's \$100 entry fee must be received prior to set-up on Wednesday, December 4, 2024.
